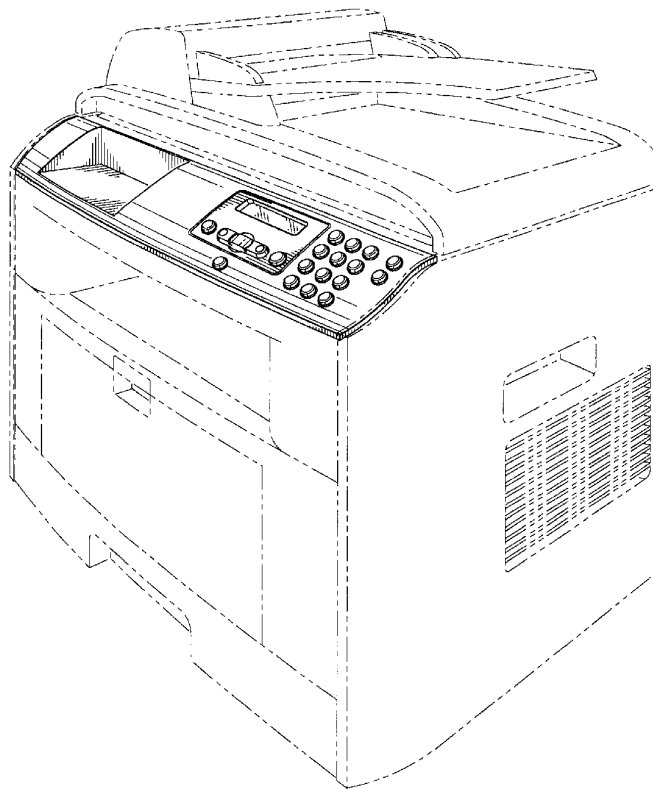
The ornamental design for a printer operator panel, as shown.

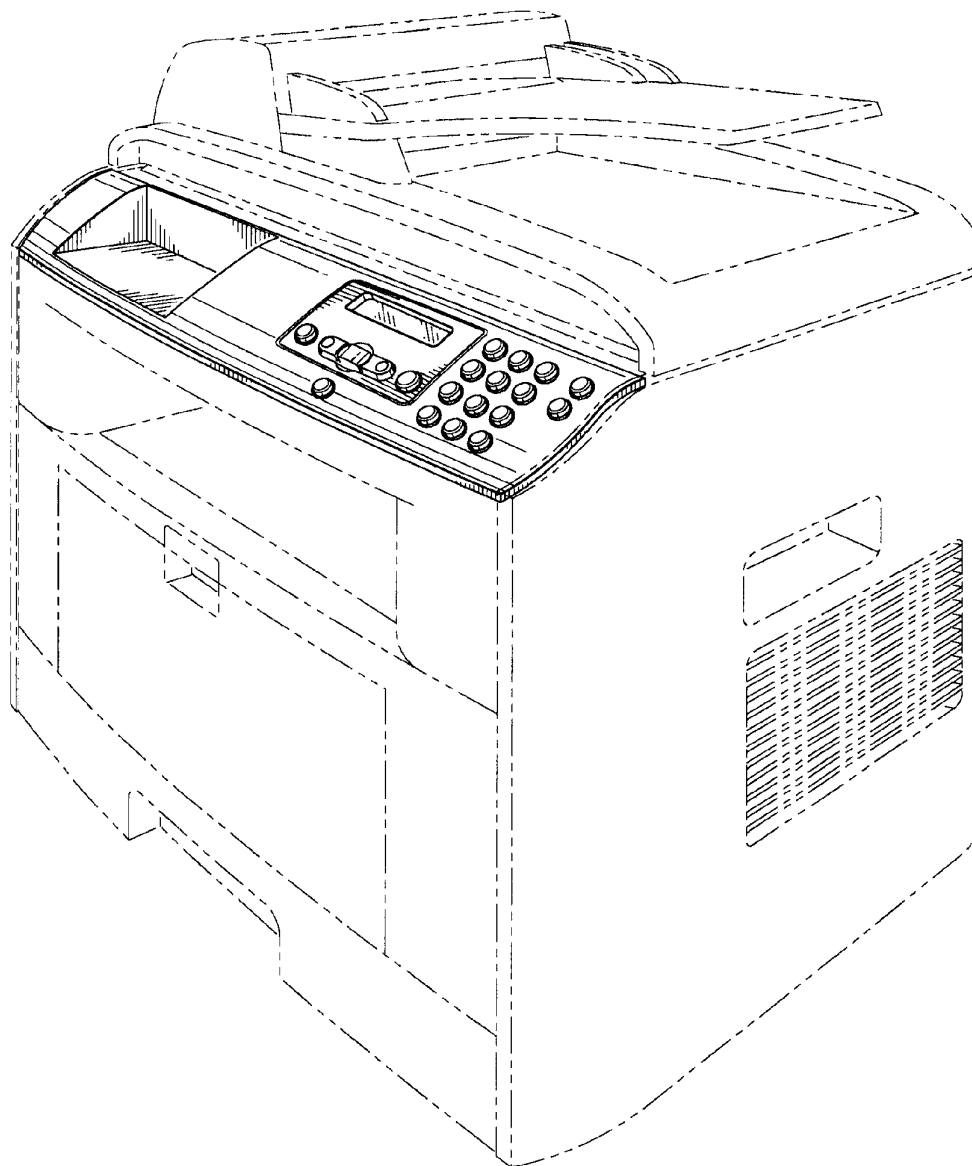

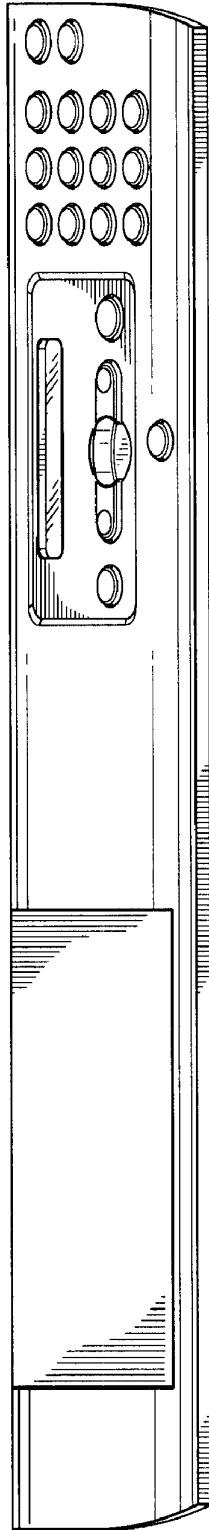

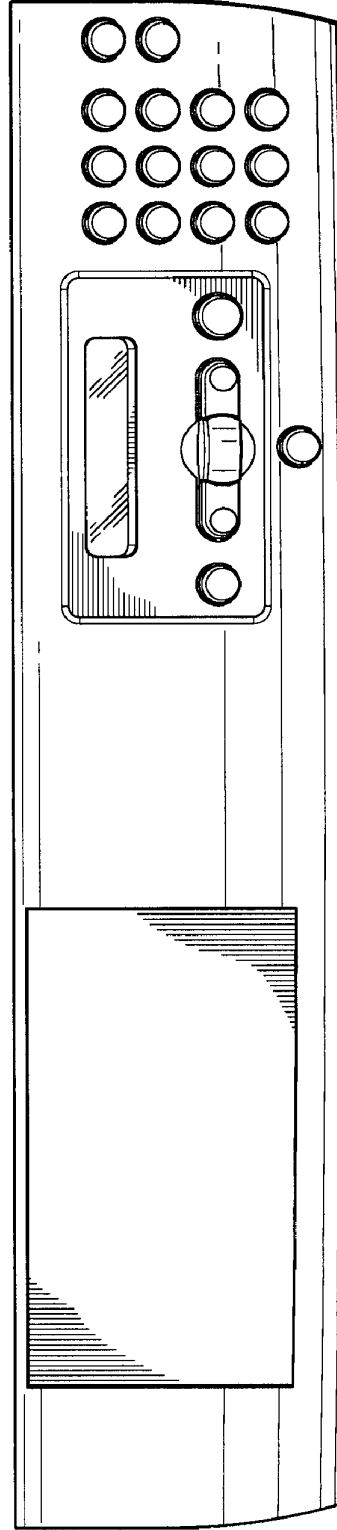
